TERMS AND CONDITIONS

THE TOUR PRICE INCLUDES

Air Transportation Economy classes, Round Trip airfares are based on the time of the reservation, Rates and Times are subject to change without notice.

Airfares once issued ARE NON-REFUNDABLE, NON -TRANSFERABLE AND CAN'T BE USED TOWARDS FUTURE TRAVEL.

Surface Transportation All surface transportation as described in the itinerary will be by Deluxe Motor Coach, some may be equipped with WI-FI service.

Hotels First class Hotels (4 or 5 Star). Hotel rooms are double occupancy (2 people per room with private bath).

Single Room There is an additional cost per person. Single rooms are limited and will be awarded on a first come first serve basis.

Meal Plan The meal plan offers 2 meals per day and consists of both breakfast and dinner. You are responsible for your lunch.

Baggage Nativity Pilgrimage limits all tour passengers to 1 piece of checked luggage and 1 carry-on (All Passengers should check with the airline carries for up-to-date baggage weight and dimension).

BOOKING CONDITIONS

A non-refundable deposit of \$500.00 per person is required at the time of booking. No reservation will be processed without a deposit.

Final payment is due 90 days prior to your departure date. Registrations received late within 60 days of departure will require Payment in Full. No deposits will be accepted at this time.

WE ACCEPT CASH, CHECKS, MONEY ORDERS AND MAJOR CREDIT CARDS. THERE IS AN EXTRA 3% CHARGE FOR CREDIT CARD PAYMENTS ON THE BALANCE.

CANCELLATION AND REFUND POLICY

All cancellations must be received in writing via fax, email, or US Mail at least 90 days prior to departure. All refunds are subject to an administrative processing fee of \$100.00 per person (No Exceptions). Cancellations made 89 to 35 days prior to departure date are subject to an administrative processing fee of \$300.00 per person (No Exceptions). Cancellations received 35 days or less prior to departure are responsible to pay the equivalent of 75% of the cost of the tour from the gateway city. It is the responsibility of the traveler(s) to connect with their tour. There is **NO REFUND** if traveler(s) fails to connect or not show up for their tour (No Exceptions). Traveler(s) on tour who miss their connections (ground or air) are responsible to pay for any additional expenses they have incurred (No Exceptions). Cancellation due to medical reasons must be certified in writing by a physician on the appropriate medical stationary and must meet the guidelines (under illness) required by the airline and our agents. Cancellation refunds are subject to an administrative processing fee of \$300.00 per person (No Exceptions).
